Pier Carlo Padoan

Pier Carlo Padoan has been a member of the Chamber of Deputies (the Italian Parliament's Lower House) since March 2018.

He was previously Minister of Economy and Finance from February 2014 until May 2018.

He was Chief Economist of the OECD from 2009 to 2014 and Deputy Secretary-General of the OECD from 2007 to 2009. In addition to heading the Economics Department, he was the G20 Finance Deputy for the OECD and also led the Strategic Response, Green Growth, and Innovation initiatives of the Organization and helped build the necessary synergies between the work of the Economics department and that of other Directorates.

In 2006 he was Director of the Fondazione Italianieuropei, a policy think-tank focusing on economic and social issues.

He was the Italian Executive Director at the International Monetary Fund (2001-2005), where he served as a member of the Board and chaired a number of Board Committees. During his mandate at the IMF he was also in charge of European Coordination.

From 1998 to 2001, he served as Economic Adviser, in charge of international economic policies, to the Italian Prime Ministers Massimo D'Alema and Giuliano Amato. He was responsible for coordinating the Italian position in the Agenda 2000 negotiations for the EU budget, Lisbon Agenda, European Council, bilateral meetings, and G8 Summits.

He has been a consultant to the World Bank, the European Commission, and the European Central Bank.

He was Professor of Economics at the University La Sapienza of Rome. He has held various academic positions at Italian and foreign universities, including the University of Rome, the College of Europe (Bruges and Warsaw), the Université Libre de Bruxelles, the University of Urbino (Italy), the Universidad de la Plata, and the University of Tokyo.

He has published widely in international and prestigious academic journals and is the author and editor of several books.
